2.0 Essential Education Qualifications and Eligibility :

(A) For Technician (Diploma) Apprentices:-

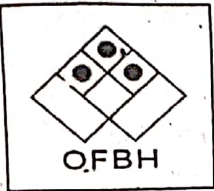

- (2.) Diploma in Electrical Engineering

(B) For General Streams Graduate Apprentices:-

Graduate Degree in General Streams (such as B.Sc./B.Com./B.A.) from the recognized University.

3.0 A candidate is not eligible to undergo apprenticeship training if the gap is more than two years.

- 4.0 If the gap between the date of declaration of result and date of commencement of training is more than one year, an affidavit on stamp paper duly signed by Magistrate/Notary has to be submitted by the candidate, matter of the affidavit will remain same as of declaration in the format given.
- 5.0 **Qualifying /Age limit :** As per apprenticeship Act to undergo Apprenticeship training, the minimum age limit is 14 years and there is no upper age limit. However, the candidates between 14-18 years are not eligible to sign the Contracts being the minor. Their contracts are required to be signed by their Guardians.
- 6.0 **Period of Training:** - One year. Training shall be terminated after completion of one year.
- 7.0 This is purely a training course & thus any claim of employment after completion of training does not arise.
- 8.0 The selection can be cancelled at any time before or during the training of one year, if any document or information is found incorrect.
- 9.0 In complete application/application received after the due date will be automatically **REJECTED** & no complaints/representation will be entertained in this regard.
- 10.0 No Hostel accommodation will be provided to the selected candidates by Ordnance Factory Bhusawal. Government quarters will be issued on request of candidates subject to availability at O.F.Bhusawal on paid basis as per YIL/HQ policy.
- 11.0 No traveling expenses will be provided to the selected candidates if the candidate has called for document verification, medical examination and registration process.
- 12.0 **Important dates/Calendar Events:** - Last date for receipt of application at Ordnance Factory Bhusawal is 21 days from the date of last publication of advertisement in news paper/ddpdoo Portal/NATS Portal.

 (ii) For Graduate Apprentices :- Rs. 9000/- per month consolidated.
- 14.0 **Standard of Physical Fitness:** As per the Apprentices Act-1961, Apprenticeship Rules 1992 and amended thereof
- 15.0 **Reservation:-** As per Apprentices Act.
 (a) A copy of certificate from competent issuing authority is required to be submitted for obtaining reservation for SC/ST/OBC & PH.
 (b) OBC candidates are required to submit Non-Creamy-layer certificate (NCLC) valid as on closing date of receipt of application.
 (c) The PH candidates will be placed on selection in appropriate category wise i.e. UR/OBC/SC & ST. Provisionally selected candidates in PH category will be confirming subject to verification PH Certificate issued by Civil Surgeon.
 (d) Candidates not having valid certificate in respect of reservation will be considered as unreserved candidate.

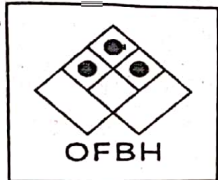

17.0 Application is to be forwarded in sealed envelope with title as "APPLICATION FOR THE POST OF TECHNICIAN (DIPLOMA) OR GENERAL STREAMS GRADUATE APPRENTICE TRAINING (Group code is necessary) with self attested photo copies of mark sheets of all semester, caste certificate, Non-creamy-Layer certificate (if applicable) and other required Certificates.

9.0 Mode of selection & joining process of the candidates:-

- Candidates will be selected only on merit, no interview or test will be taken for the selection.
- For preparation of merit list, in case of two candidates having the same marks/percentage (tie case) the candidates with older age shall be preferred. If the dates of birth are also the same then the candidates who passed Matriculation examination earlier (year) shall be considered first. Even if the year of passing of Matriculation examination is same, the candidate name in alphabetical order appearing first will be considered first.
- Wherever, CGPA/OGPA/DGPA or letter Grade in a degree is awarded, its equivalent percentage of marks must be indicated in the application form as per norms adopted by University/Institute. Proof of norms adopted by the University/Institute to convert CGPA/OGPA/DGPA in to percentage is necessary to submit by the selected candidates at the time of verification of documents.
- Merit list will be published on the notice board of Main Gate of OFBH and selected candidates will be called for the verification of documents.
- Candidates have to submit all desired documents during document verification. In case of failure to submit any of the desired documents, the candidate will not be permitted for further process.
- After verification of documents of selected candidates police verification will be carried out. Selected candidates will be called for medical examination before joining after receipt of clear PVRs.

- vii) Engagement of selected candidates will be subject to their passing the Medical Examination conducted by OFB Hospital.
- viii) It is mandatory for the selected candidates to register themselves on NATS 2.0 Portal www.khrdnats.gov.in and the same will be verified on the day of document verification. Selected candidates will not be allowed to join for training until the candidates complete the total registration process on NATS 2.0 Portal and after generating their contract registration form on NATS 2.0 Portal successfully only.
- ix) A waiting list will also be created while publishing the merit list.
- x) No Hostel accommodation will be provided to the selected candidates by Ordnance Factory Bhusawal.
- xi) If the gap is more than one year, the affidavit has to be furnished on stamp paper as per the given format (Annexure 'C').
- xii) Copy of declaration/affidavit to be submitted along with application form (Annexure ' B ')
- xiii) No traveling expenses will be paid to the selected candidates if the candidate has called for document verification, medical examination and registration process.

A security bond will be taken from the selected candidates in case the candidates leave during the training.

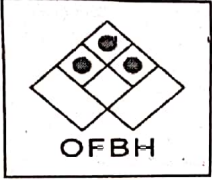
